COULD HAVE AVOIDED IT. HOW ABOUT THEM? DESCRIBE HOW THEY WERE AT
DESCRIBE FULLY WHAT CAUSED THE ACCIDENT. SOMETIMES THEY ASK HOW YOU
INFIRMARY (AND GET TREATMENT) AND SECURITY. BE CAREFUL OF THE FORMS.
1. REPORT THE ACCIDENT AND YOUR INJURIES RIGHT AWAY TO SHIP'S

5 STEPS TO TAKE IF YOU ARE INJURED ON A CRUISE SHIP

10 STEPS TO TAKE IF YOU'RE SEXUALLY ASSAULTED ON A CRUISE SHIP

- 1. REPORT THE CRIME RIGHT AWAY TO SHIP'S INFIRMARY.** INSIST ON PHYSICAL EXAM AND RAPE KIT.
- 2. REPORT THE CRIME RIGHT AWAY TO FBI.** CALL FBI YOURSELF OR HAVE FAMILY OR FRIEND CALL. DO NOT ALLOW THE SHIP TO CALL FOR YOU. THEY LOOK OUT FOR THEMSELVES, NOT FOR YOU. FBI: 1.800.225.5324
- 3. PHOTOS.** HAVE FAMILY OR FRIEND TAKE PHOTOS OF ALL BRUISES, SCRATCHES, CUTS, AND OTHER INJURIES. (A PICTURE IS WORTH A THOUSAND WORDS. THE CRUISE LINE MAY NOT GIVE YOU THEIR PHOTOS...EVER). ALSO TAKE PHOTOS OF THE ROOM OR AREA WHERE IT HAPPENED AND OF THE ATTACKER IF YOU CAN.
- 4. GET FULL NAME, TITLE (IF SHIP EMPLOYEE), AND HOME ADDRESS OF ATTACKER.**
- 5. GET FULL NAME, ADDRESS, EMAIL, AND CELL NO. OF ALL WITNESSES TO ATTACK, ATTACKER, OR NOTICE TO THE CRUISE LINE BEFORE ATTACK HAPPENED**
- 6. PUT IN A ZIP LOCK AND DO NOT WASH THE CLOTHES YOU WERE WEARING WHEN ATTACKED.**
- 7. REPORT TO A RAPE TREATMENT CENTER OR HOSPITAL ER ON LAND RIGHT AWAY.**
- 8. GET ALL OF THE MEDICAL CARE FOR YOUR INJURIES STARTING RIGHT AWAY.**
- 9. GET COUNSELING FROM A PSYCHOLOGIST, PSYCHIATRIST, LICENSED MENTAL HEALTH COUNSELOR, OR MASTERS IN SOCIAL WORK CERTIFIED PROFESSIONAL.**
